

Report of the Senior Officials' Meeting (SOM) of the 15th ACD Ministerial Meeting Monday 16th January 2017, 3.00 PM - 7.00 PM Anantara Eastern Mangrove Hotel, Abu Dhabi, United Arab Emirates

- (1) The Senior Officials' Meeting (SOM) of the 15th Asia Cooperation Dialogue (ACD) Ministerial Meeting took place on Monday 16th January 2017 at Ballrom, Anantara Eastern Mangrove Hotel, Abu Dhabi, United Arab Emirates.
- (2) The United Arab Emirates by H.E. Mohammed Sharaf, Assistance Foreign Minister of Economic Affairs, as the ACD Chair and the host of the Senior Officials' Meeting (SOM) of the 15th ACD Ministerial Meeting welcomed all distinguished delegates to the Senior Officials' Meeting and expressed appreciation for all participations. The Chair, then, adopted the agenda of SOM and highlighted the importance of ACD as the forum for Asia region.
- (3) The Past Chair, the Kingdom of Thailand, by H.E. Mr. Chutintorn Gongsakdi, started his statement with expressing Thailand's appreciation to the UAE government for the leadership and efforts.
 - After expressed appreciation to the Prime Movers and all the Co-Prime Movers in the pillar of Food, Energy and Water Security for their seriousness, as reflected in the Prime and Co-prime Movers' Consultation on 20 December 2016 and the (renewed) ACD Energy Action Plan, H.E. Mr. Chutintorn Gongsakdi expressed Thailand's interest in joining all the Working Groups in the near future.
 - With regards to the pillar Promoting Approaches to Inclusive and Sustainable Development, Thailand, as the Prime Mover of this pillar, affirmed their respect to each country's home-grown approaches to development, for example the "Sufficiency Economy Philosophy" by the late King Bhumibol Adulyadej. In this relation, Thailand (1) proposed the establishment of the ACD Working Group on Sustainable Development in August 2017; (2) expressed interest in convening a consultation with the Co-Prime Movers within the pillar Promoting Approaches to Inclusive and Sustainable Development; and (3) informed the meeting that Thailand has circulated a Concept Note on "Promoting Approaches to Inclusive and Sustainable Development" through the ACD Secretariat for comments from Co-Prime Movers of this pillar.
 - In this relation, Thailand expressed intention to launch an international training programme on "Microcredit and Sufficiency Economy Development" during 20 August 2 September 2017, and informed the meeting that 20 participants from ACD Member States will be invited to this training programme (number is still flexible) and encouraged the ACD Member States to express your interests to Thailand or through the ACD Secretariat at the earliest opportunity.



- H.E. Mr. Chutintorn Gongsakdi continued his statement by highlighting the importance of nexus approach to food, energy and water security as a way to build Asia's synergies and greater efficiency, and inform the meeting that, Thailand, as the host of the 7th Asian Ministerial Energy Roundtable (AMER) in November 2017, is considering to host an ACD-related event back-to-back or as a side event of the AMER Meeting. At the end of his statement, referring to the 2nd ACD Summit, he expressed his hope for an appropriate legal status and a concluded host country agreement between the ACD Secretariat and the Government of Kuwait to reassure the effective operation of the ACD process.
- (4) The ACD Secretary General, Mr. Bundit Limschoon, made a report of Past ACD Activities (2015-2016) and Anticipated Activities ACD Activities (2017-2018) by highlighting the progress of ACD's cooperation under the 6 priority pillars.
 - He started with the pillar Interrelation of Food, Water, and Energy Security by thanking the UAE for hosting the High-level Meeting of Prime and Co-prime Movers' Consultation on 20 December 2016. The said meeting underlined the importance of nexus of the three elements (food, water and energy) as well as method and scope of work with due consideration to the important role of private sector and academia, technology, innovation, research and development (R&D). The result of such consultation is reflected in the Energy Action Plan, which was endorsed by the Energy Working Group on 15 January 2016.
 - The ACD Secretary General continued with the progress of pillar Education and Human Resource development, in which the Kingdom of Saudi Arabia, as the Prime Mover, took the first step forward by inviting the ACD Secretariat to Riyadh in October 2016 to consult with high-level officials from related authorities.
 - He, then, reported the progress of the pillar Culture and Tourism by underscoring the close coordination between the Secretariat and the Government of the Kingdom of Cambodia in preparing for the 2nd ACD Ministerial Meeting on Tourism, which will be held in Siem Reap, Cambodia during 12-15 June 2017.
 - He also reported the progress of the pillar Promoting Approaches to Inclusive and Sustainable Development by informing the meeting that Thailand, as the Prime Mover, has circulated the concept note to its Co-Prime Movers for consideration and announced an open-ended Working Group Meeting on Sustainable Development.

After encouraged the other Prime and Co-prime Movers to communicate within their pillars, the Secretary General mentioned the initiative of the roundtable meeting of Secretaries-General of forums and organisations in Asia, which the Kingdom of Bahrain offered to host the said meeting in 2017. The purpose of the meeting is according to paragraph no. 6 of the Bangkok Declaration encouraging ACD to establish and promote dialogues with international, regional and sub-regional forums and organisations in Asia. The Secretary general concluded his report by highlighting that, in accordance with the paragraph no. 5 of



Bangkok Declaration, the ACD Secretariat is working closely with the Government of Kuwait to develop further refinements to the Secretariat's operation, such as ACD's appropriate legal status, the effective operation of the ACD Secretariat.

- (5) The Meeting approved the draft agenda and format of the 15th ACD Ministerial Meeting, then, discussed the two outcome documents of the 15th ACD Ministerial Meeting, namely, Abu Dhabi Declaration and (renewed) ACD Energy Action Plan. The SOM focused on the three pending issues from the Drafting Committee which are (a) Malaysia's proposal of to acknowledge the importance of moderation as a balanced approach, (b) Bahrain's proposal to host the ACD Meeting with other Secretaries General of regional organizations/fora in Asia and (c) Japan, China, Russia and Kazakhstan's proposals to include their initiatives in the Declaration.
- (6) At the end of the meeting, all ACD Member States agreed upon the draft Declaration and draft (renewed) ACD Energy Action Plan to be tabled for all Ministers' consideration tomorrow, however with a reservation from Russia on the Malaysia's proposal to include the word moderation. The Chair recommended Russia and Malaysia to finalize the said issue before the Ministerial Meeting on 17 January 2017.
- (7) The Chair expressed his appreciation and concluded the meeting.
